THE RDCBS (Owner) AND THE MEMBER AGREE AS FOLLOWS:

1. Description of Instrument: The Member agrees to keep in their care, custody, and control the musical instrument described in the Schedule attached to this agreement (the "Instrument").
2. Rent: No rent will be payable for the duration the instrument remains in possession of the Band Member.
3. Term: This agreement shall be for a term of an agreed upon length of time between the two parties, giving the RDCBS (Owner) the right to request the instrument back at any time.
4. Condition of Instrument: The RDCBS (Owner) shall make the Instrument available to the Member for inspection on the Effective Date, and upon taking possession of the Instrument, the Member shall acknowledge that the Instrument is in the condition described in the Schedule.
6. Use, Maintenance and Repair: The Member shall keep the Instrument in good working order, and inform the RDCBS (Owner) of any repairs, requirements and/or maintenance. If the instrument is in the care, custody, and control of the Member at the time of the Instrument being damaged or lost, it is the Member's responsibility to repair or replace the instrument.
7. Termination: This Agreement may be terminated by the Member at the end of the agreed term simply by returning the Instrument in good working condition (only reasonable wear and tear will be excepted) to the RDCBS (Owner) Instrument, and any repairs that the RDCBS (Owner) deems necessary to restore the Instrument to good working condition will be charged to the Member.
8. Liability Waiver: The RDCBS (Owner) shall not be liable for any injury or loss sustained by the Member by the operation, handling or transportation of the Instrument during the term.
9. Insurance: It is understood and agreed that in the event of a claim, the Member is responsible for the repair/replacement of the instrument under his/her own insurance policy. At the time of any incident, the value of the instrument will be advised by the RDCBS (Owner).
